INVITATION FOR TENDERS

Supply of district heating network pumps, fans and frequency converters

This Invitation for Tenders follows the General Procurement Notice for this project which was published on the European Bank for Reconstruction and Development (the Bank) website, Procurement Notices (www.ebrd.com) on May 27, 2016.

SA CET-Nord hereinafter referred to as "the Purchaser", intends to use part of the proceeds of a loan from the Bank) and a grant from the Eastern Europe Energy Efficiency and Environmental Partnership (E5P) Regional Fund, administrated by the Bank, towards the cost of Balti District Heating Project.

The Purchaser now invites sealed tenders from Suppliers for the following Contracts to be funded from part of the proceeds of the loan:

- Lot 1 Supply of district heating network pumps and frequency converters
- Lot 2 Supply of air FD fans, flue gas ID fans and frequency converters

Location: SA CET-Nord, 168 Stefan cel Mare Str, MD 3121, Bălți, Moldova.

The Lots will be implemented concurrently and should be completed within 5 months.

The Tenderer shall include and emphasize separately the Related Services in his tender.

Tenders are invited for one or more lots. Each lot must be priced separately. Tenders for more than one lot may offer discounts and such discounts will be considered in the comparison of tenders.

Tendering for contracts that are to be financed with the proceeds of a loan from the Bank is open to firms from any country. The proceeds of the Bank's loan will not be used for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import is prohibited





by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations.

To be qualified for the award of a Contract, Tenderers must satisfy the following minimum criteria:

For Lot 1:

- Average annual turnover as prime Supplier over the last 5 years (2012-2016) of EUR 2,700,000
 equivalent
- Access to, or available, liquid assets, unencumbered real assets, lines of credit, and other financial
 means sufficient to meet the production cash flow for the contract estimated as not less than EUR
 650,000 equivalent
- Experience as Supplier, in at least **2 contracts** within the last **5 years** (2012-2016), each with a value of at least **EUR 500,000**, that have been successfully and substantially completed and that are similar to the proposed Goods.

For Lot No.2

- Average annual turnover as prime Supplier over the last 5 years (2012-2016) of not less than EUR
 1,800,000 equivalent
- Access to, or available, liquid assets, unencumbered real assets, lines of credit, and other financial
 means sufficient to meet the production cash flow for the contract estimated as not less than EUR
 400,000 equivalent
- Experience as Supplier, in at least 2 contracts within the last 5 years (2012-2016), each with a value
 of at least EUR 320,000, that have been successfully and substantially completed and that are
 similar to the proposed Goods.

and other criteria specified in the tender documents for both Lots, including to Contractor's personnel and equipment, etc. Tenderers submitting tenders for both Lot shall meet the qualification criteria for both Lots.

All tenders must be accompanied by a tender security of EUR 15,000 for Lot 1 and EUR 10,000 for Lot 2, or its equivalent in MDL.

Tenders must be delivered to the office at the address below on or before 17 April 2018, 12:00 noon, at which time they will be opened in the presence of those Tenderers' representatives who choose to attend.
