Since 2015, get-e-right GmbH has provided the mandatory WEEE authorised representative in Germany for international producers without a German branch and has since rounded off the services of take-e-way with regard to the legal requirements of the amended ElektroG. In addition, get-e-right also offers the authorisation according to the BattG and the VerpackG. In addition, the solution for WEEE was extended to France in 2018. get-e-right is part of the e-systems group, which also operates its own academy for product compliance.

Role of the authorised representative

Role of the authorised representative



- Conclusion of binding contracts on behalf of the producer
- Registration with the authorities
- Submission of quantity reports to the take-back system on behalf of the producer
- Representation towards authorities as contact person
- Assumption of liability pursuant to the Administrative Penal Act



Administrational

- The authorised representative acts in the interest of the producer in such a way that the legal requirements are fulfilled
- The authorised representative assumes the obligations of the producer and is thus the first point of contact for authorities in Austria
- Application of a comprehensive control and quality assurance system
- Conclusion of contracts and data exchange with take-back systems
- Cooperation with authorities and coordination bodies during audits





05 The get-e-right solution

AR registration, notification, control and quality process

Foreign producers apply for a registration in AT, according to a standard process based on the respective waste stream (WEEE, Batteries, Packaging) and details of the product portfolio.



The initial risk assessment and qualification is being carried out by take-e-way to identify subsequent enforcement risks and ensure a smooth registration and monitoring process.



The producer appoints get-eright as authorised representative. All relevant documents are provided and allow a quick and smooth registration process.

Based on the get-e-right **power of attorney process**, certification of the correctness and credibility of all documents.



The further registration process is being carried out by take-e-way as a vicarious agent according to standardised procedures with the ARA and, in future, also with the coordinating bodies.



The take-e-way Customer Online Portal (monthly reporting) offers the optimal platform for both the producers (reporting, plausibility check, archiving and reminder function) and the authorised representative (monitoring, checks).

For the preparation and attendance of **rotational** audits ordered by the competent authority, getright shall charge the producer an expense allowance at a daily rate of € 1,500 plus travel and accommodation expenses (in the case of possibly scheduled on-site audits).
